Drug Enforcement Administration Special Testing and Research Laboratory

The Special Testing and Research Laboratory's Emerging Trends Program compiled the data for this report through a query of archived seizure and analysis information from drug evidence analyzed by the Drug Enforcement Administration's laboratory system. This data is representative of drug evidence seized and analyzed in the date ranges annotated. This is not a comprehensive list of all new psychoactive substances and is not representative of all evidence analyzed by DEA. This data is an annual snapshot of the new psychoactive substance market in the United States.

The term new psychoactive substance (NPS) describes a recently emerged drug that may pose a public health threat. This includes synthetic cannabinoids, substituted cathinones, phenethylamines, opioids, tryptamines, benzodiazepines, and a variety of other chemical classes. Due to the increase in seizures over the last several years, fentanyl is also included in this report.

An identification is made when authenticated reference material is available for comparison. When reference material is not available, the drug evidence is identified as "substance unconfirmed" or "inconclusive." A single unit of drug evidence may have multiple sub-units. For the purposes of this document, each unit of drug evidence counts as one identification regardless of the number of sub-units. Some seized drug evidence contains more than one active ingredient; therefore, more than one identification can be made for a single unit.




DESIGNER BENZODIAZEPINES

INTERNET (DESIGNER) BENZODIAZEPINES

- diclazepam, flubromazepam and pyrazolami, clonazolam, deschloroetizolam, flubromazolam, nifoxipam and meclonazepam)
- 30+ have been identified
- Often previously developed by drug companies and research institutions but never approved or deemed appropriate for human use
- Often every little information on the pharmacokinetics, safety profile
- Considered schedule I drugs in some states



EMERGING THREAT REPORT 2020

BENZODIAZEPINES

THERE WERE 295 IDENTIFICATIONS OF DESIGNER BENZODIAZEPINES DURING THIS REPORTING PERIOD. THIS REPRESENTES AN
APPROXIMATELY 157% INCREASE FROM CY2019. FLUALPRAZOLAM AND ETIZOLAM WERE THE MOST REPORTED DESIGNER
BENZODIAZEPINES ACCOUNTING FOR APPROXIMATELY 81% OF
THE IDENTIFICATIONS.

- Oct 6, 2020- March 9 2021
- 141 samples from 5 clinical sites (Missouri, Oregon, NY and Penn)
- Patients were treated in emergency rooms for suspected opioid overdose
- 21 (14.9%) had an illicit benzodiazepine
 - 11 clonazolam
 - 10 etizolam
 - 2 flubromazolam


Clonazolam

- Clonazepam + Alprazolam (2 most recognized prescription benzo)
- First synthesized in 1971
- Sold on the internet as research chemicals "not for human consumption", typically European sources
- Sold as pills and liquid




Presentation

- Lethargy and somulance
- Walking amnesia, respiratory depression
- Overdose does not respond to Narcan
- Duration of effect (2-24hr), typically 8-24
- Very potent, profound sedation at 0.5mg
- Hepatically metabolized and excreted in the urine
- Will trigger a positive screen but negative confirmation
- High variation in dosing of pills (0.7-8.3mg)



Presentation

- Usually co occurring drug use (opioids)
- Patients may be on prescribed benzos but feel they need more or higher doses
- Patients may have a hx of benzo use but are cut off and seek alternatives
- May present like benzo withdrawal that persists or is out of proportion to the level of benzos they report
- If patient appears to be under influence of benzo have high suspicion
- Can be reversed with flumazenil



Etilozam

- short acting
- -similar in potency to Xanax
- -prescribed in far East


NPS OPIOIDS

- Etonitazene Schedule I- developed in the 1950s
- Clonitazene Schedule I
- Metonitazene
- Flunitazene
- Isonitazene
- Etodesnitazene
- Metodesnitazene

Etonitazene has 1000 fold greater affinity for mu receptor (in mice), probably 60 times more potent than morphine


Never approved due to respiratory depression so severe





Isotonitazine (ISO)

- Seizure of 1900 pressed pills in Novia Scotia to look like dilaudid
- Data from the Ohio Bureau of Criminal Investigation finds that isotonitazene has been identified in the state at least 11 times since the start of 2020.




Isotonitazine (ISO)


- First appeared on line 2018
- Chinese crack down on lab production of fentanyl (put to death a fentanyl manufacturer) 11/2018
- First reported in US in 2019
- Case of overdose deaths in Peoria Illinois
- 7 known cases of overdose in Indiana 2020

Isotonitazine (ISO)

- Even more potent than fentanyl (slightly)
- Like fentanyl the patient may not be aware what they are taking (in Indiana found in conjunction with cocaine use)
- Not well studied, post mortem data mostly
- Will not show up in urine drug screens

- Typical cycle for NPS opioids
 - drug is first synthesized and is unscheduled
 - drug is sold on line
 - drug is detected by forensic labs (NPS discovery)
 - drug is restricted at state levels then DEA
 - in about 6-12 months use declines
- Unlikely these NPS opioids will replace fentanyl and its derivatives

- Natural occurring cathinone (Khat)
- Chewed as a mild stimulant

PERIOD. THIS REPRESENTES AN APPROXIMATELY 9% INCREASE FROM CY2019. EUTYLONE WAS THE MOST REPORTED CATHINONE, ACCOUNTING FOR APPROXIMATELY 77% OF THE IDENTIFICATIONS.





Figure 55. Ten Most Frequently Reported Synthetic Cathinones to NFLIS-Drug by Percentage, 2019

Synthetic cathinones

- Stimulant and empathogenic
- powder
- Sold in small packets as bath salts, plant food, cleaner...
- Often found in produces sold as Molly (MDMA or Ectasy)
- Can be swallowed, snorted, smoked
- Increase dopamine, serotonin and norepinephrine levels

Eutylone

- Sold in pills as MDMA (ectasy) or "Red bull, Blue Playboy"
- Produces a weaker effect then Ectasy so the user takes more leading to the toxicity
- 11/5- DEA seizes 3 kg of Eutylone in Virginia

PRESENTATION

- Stimulant
- Paranoia
- Hallucinations
- Excited delirium
- Panic attacks
- Increased sexual activity
- Agitated delirium
- Dilated pupils, hypertension, tachycardia
- Increased locomotor activity (bruxism, repetitive movements)

Cathinone Withdrawal


- Similar to stimulant withdrawal
- Anhedonia and depression
- Insomnia
- Anxiety

URINE DRUG TESTING

May show up as amphetamine at high doses but cross reactivity is generally poor



SYNTHETIC CANNABINOIDS

THERE WERE 134 SYNTHETIC CANNABINOID IDENTIFICATIONS IN

CY2020. THIS REPRESENTS AN APPROXIMATELY 23% DECREASE FROM CY2019. 5F-MDMB-PICA AND MDMB-4EN-PINACA WERE THE MOST COMMONLY REPORTED SYNTHETIC CANNABINOIDS ACCOUNTING FOR APPROX-

IMATELY 66% OF THE IDENTIFICATIONS.



Synthetic Cannabinoids

- Generally sprayed on some plant material for smoking
- Vaping products now, impregnated paper
- Very potent binders to the cannabinoid receptor (CB1)
- Bind to the cannabinoid receptor but with stronger affinity
- Significant variation between products and within a product
- Lack the CBD component which is protective against psychosis

- To avoid positive urine drug screens but want to smoke THC
- Still easily obtained on line
- Low cost
- Seen in poorer socioeconomic groups (can buy some with \$2-\$5)

PRESENTATION OF SYNTHETIC CANNABIS

- Can vary greatly
- Feeling relaxed and mild changes in perception
- Confusion, disorganized thought,
- Agitation , restlessness
- Anxiety, irritability
- Paranoia, perception distortion, delusions, hallucinations
- Tachycardia, hypertension

SYNTHETIC CANNABIS WITHDRAWAL

- Peak earlier (1-2 days) than THC and more severe
- Can see psychosis and seizures unlike THC
