



What is First Steps?

 Early intervention services for children birth to 3 years old with developmental delays or at risk for developmental delays

 Established and funded through federal law and state rules (IDEA Part C)

 Provides early intervention services that can help eliminate/reduce the need for later services and thus save costs.

Mission

To partner with Hoosier families whose young children are experiencing developmental delays and connect them with services that help them promote their child's development.


Vision

 The state of Indiana is divided into 9 service regions called Clusters



 Each Cluster is required to have a System Point of Entry (SPOE)

 There are 38 Provider Agencies statewide



Who is eligible for First Steps services?

- ~ An infant/toddler who is 0-3 years old.
- ~They must have a developmental delay or have a diagnosed medical condition that makes it likely that they will develop a delay.
- ~Specifically, there must be a 25% delay in one area or a 20% delay in two or more areas of development:
 - Cognitive
 - Physical (gross motor, fine motor)
 - Communication (receptive and expressive)
 - Social/emotional development
 - Adaptive skills

Medical categories of eligibility for Part C services:

- Chromosomal abnormalities
- Genetic or congenital disorders
- Sensory impairment including vision or hearing
- Inborn errors of metabolism
- Neurological abnormality in newborn period
- Congenital infection
- Low birth weight (1500 grams/3.1 pounds)
- Severe attachment disorders
- Severe toxic exposure pre and postnatal exposure (including FAS)
- **accurate ICD 10 codes on referrals are helpful

Evaluation & Assessment Tool



The State of Indiana has chosen the Assessment Evaluation and Programming System (AEPS). Which is a comprehensive curriculum-based assessment.

~The purpose of assessment is to:
help establish eligibility for services and to
develop meaningful, functional, and developmentally
appropriate outcomes/goals.





The **IFSP** is a process and a legal document that considers a family's priorities, concerns, and resources regarding their child with special needs.

The purpose of the **IFSP** is to identify and organize resources to facilitate priorities and goals for the child in the context of their family.

How and where First Steps services occur...

firster

~The family is the center of First Steps services and family engagement is key.

~First Steps builds upon the parent/professional relationship and supports parents as the advocate for their child.

~The goal is to work with the family/caregivers to develop a plan which educates and empowers.

~"Natural Environments" are places and routines that are typical for the child and family.

Anyone can refer a child to First Steps...

- Parents
- Physician
- Childcare Provider
- Grandma
- Etc.



What is the referral process?

Step 1: A referral is made to a local SPOE office

Step 2: An Intake Coordinator or Service Coordinator sets up the

initial appointment with the family

Step 3: Assessment

Step 4: Eligibility meeting; the IFSP is developed

Step 5: Services begin!







How much does First Steps cost?

~There is never a fee for an eligibility evaluation.

~Regardless of eligibility, all children are entitled to service coordination.

~On-going services might include a co-pay, depending on family income and resources.

Some common myths and facts about IDEA/Part C

MYTHS...

- Early intervention services are mandatory
- Children 'qualify' for certain services
- First Steps is a medical/clinical or education model
- HIPAA requirements

FACTS...

- First Steps serves ALL children in Indiana who are birth to 3 yrs.
- Part C services follow a developmental model
- FERPA guidelines
- EI services are fluid. Children can come in and out of the program
- 45 and 30 day timelines

The total number of children and families served annually: 23,574

47% children receiving First Steps services transitioned to Special Education Preschool (IDEA Part B)



Number of children receiving each type of service:

- ❖ Speech Therapy: 15,218 (65%)
- ❖ Occupational Therapy: 13,200 (56%)
- ❖ Physical Therapy: 11,843 (50%)
- ❖ Developmental Therapy: 12,543 (53%)
- ❖ Audiology: 709 (3%)
- ❖ Nutrition: 326 (1%)
- ❖ Psychology: 167 (1%)
- ❖ Social Work: 27 (0%)
